

Mrs. Taylor County Fair Pageant

Taylor County Fairgrounds – Under the hoop tent

This pageant is open to all women over the age of 21 who are permanent Kentucky residents. Contestant must be of good moral character, married, and living with husband. Previous winners are not eligible. Failure to comply with the fair board or pageant committee and their rules and regulations may result in dismissal from the pageant. The entry fee for pre-registration is \$30.00 (please make checks payable to “Taylor County Fair”). If you choose not to pre-register, the entry fee is \$40.00 at the door, cash only. **NO REFUNDS WILL BE GIVEN.** All contestants will be required to pay gate admission into the fair. In case of rain pageant will be moved to an alternative location.

Mrs. Taylor County Fair will receive a crown, sash, flowers, and \$100.00 prize money.

Evening Gown Competition – Gown of your choice.

On-Stage Question – Top 10 contestants only.

Judging – Contestants will be judged on evening gown and on-stage question. Judges decisions are final.

Dressing Room – Only one person per contestant will be allowed. **NO MEN** allowed in dressing room.

Arrival Time – The gate will open at 5:00 p.m. EDT.

Check-In/Registration – All contestants must have their paperwork turned in by 6:30 p.m. (no exceptions). Pageant will not be held for late arrivals – **BE ON TIME.** Numbers will be drawn immediately after registration is complete.

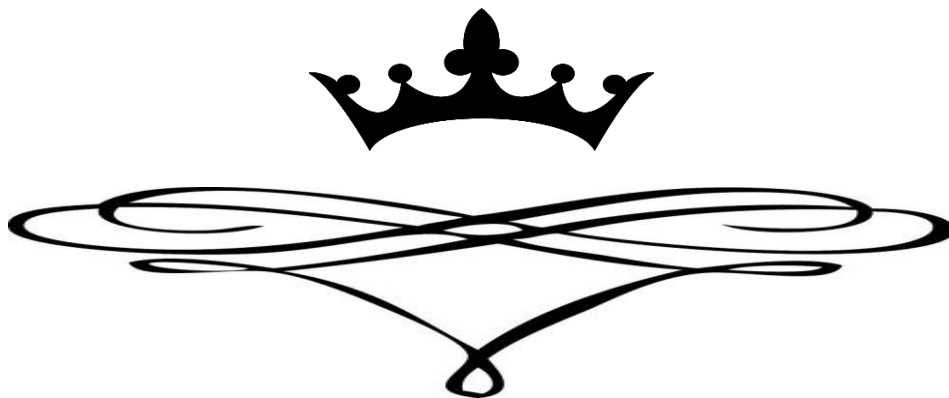
All ladies should bring a copy of their birth certificate or drivers' license to verify age.
